

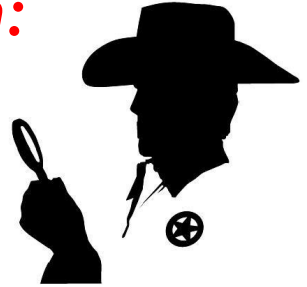

An emphasis is placed on the preparation of affidavits, preparation and execution of search and arrest warrants, interview and interrogation procedures, and the criminal investigator's role in the identification, collection and preservation of physical evidence.
