This is a hands-on course designed to teach the basic fundamentals, as well as forensic applications, of digital photography at various types of scenes. The participant will be taught how to use their department camera equipment, focusing on manual modes, manual adjustments, digital SOP's, flash operation and many other practical applications. A variety of photographic assignments will be covered to challenge each student and help prepare them for any situation they may encounter as a crime scene specialist, crime scene investigator or forensic scientist involved in investigative photography. **PREREQUISITES:** None.
